

# Job Title: Anchorum Fellow Community Liaison (Fellow)

New Mexico Foundation is proud to be one of the five community foundations in New Mexico selected to host an Anchorum Fellow Community Liaison (Fellow). The Fellow will work in partnership with Anchorum Health Foundation to ensure that community investments yield the greatest possible impact. The Fellow will serve as a critical link between the community and Anchorum, providing valuable insights into emerging and chronic trends that affect social impediments to health. The Fellow will play a vital role in shaping Anchorum's approach to grant-making and improving community health outcomes, ensuring resources are aligned with community needs and priorities. The role involves collaborating with all of the state's 23 federally recognized Tribes, Nations, and Pueblos, as well as the counties of Cibola, Guadalupe, Harding, McKinley, San Juan, and Union.

The Fellow will serve in a coordinator role, interfacing closely with the New Mexico Foundation and community organizations such as those funded by Anchorum as part of the Anchorum Health Foundation Community Health Funds. This position will report dually to the New Mexico Foundation and the Anchorum Health Foundation Fellows Program Manager.

Each Fellow will be part of the Anchorum Fellows Cohort that will meet regularly and share information and strategies but will be the employee of the respective community foundation. This position can be funded by Anchorum Health Foundation for up to five years but will be reviewed annually. The terms of the Fellow's employment will be negotiated with each of the five community foundations.

As the only statewide community foundation, New Mexico Foundation's mission is to steward community resources, build partnerships, and create opportunities that transform lives throughout New Mexico. New Mexico Foundation's Fellow will focus on Pueblos and Tribal Nations, and San Juan, Union, Harding, McKinley, Cibola, and Guadalupe counties.

# **Position Responsibilities**

**Knowledge Sharing and Liaison:** Serve as the primary liaison between New Mexico Foundation, four other community foundations and Anchorum Health Foundation (Anchorum), facilitating communication, sharing best practices, and disseminating lessons learned to promote cross-learning and collaboration across regions.

**Capacity Building:** Collaborate closely with Anchorum to identify strengths, weaknesses, and opportunities for capacity building, providing tailored support and resources to enhance New Mexico Foundation's ability to effectively address their community's health needs.

**Partnership Development:** Cultivate and strengthen partnerships with local organizations, healthcare providers, government agencies, and other stakeholders to leverage resources, share best practices, and maximize impact in addressing community health needs. Encourage partnerships with grantees in New Mexico Foundation's geographic areas funded by the initiative. Facilitate needed community engagement with elected officials at the local, state, and national level in support of current and future project delivery.

**Data Analysis and Reporting:** Collect, analyze, and interpret data on community health indicators, program outcomes, and community feedback to inform decision-making, track progress, and report on the impact and effectiveness of initiatives supported by New Mexico Foundation. Contribute to initiative-wide evaluation, impact assessment, and strategy activities to support the evolution of the initiative over time.

**Training and Education:** Provide training, technical assistance, and capacity-building workshops to community foundation staff, board members, and community partners on topics related to health equity, community development, and effective philanthropy.

**Community Outreach:** Bring together multiple stakeholders and community members to learn more about the health needs in each respective community. Hold community meetings on a variety of topics to develop relationships with community members and hear multiple voices and perspectives to inform grantmaking.

**Program Development:** Collaborate with Anchorum staff and work with local stakeholders and community residents to design and implement innovative programs and initiatives aimed at improving health equity, promoting wellness, and addressing the root causes of health challenges

# **Experience and Skills**

- Bachelor's degree in public health, social work, community development, or a related field (master's degree preferred), but equivalent experience may be substitutes for a degree.
- Proven project management skills from conception to design to implementation.
- Minimum of 5 years of experience working in community development, public health, or philanthropy, with a focus on addressing health disparities and social impediments to health.
- Demonstrated skills in facilitation, relationship building, partnership management and collaborative planning/delivery.
- Comfort and competency with working through adaptive challenges where solutions are not yet developed.

- Experience communicating effectively and working collaboratively with diverse people and communities.
- Ability to collaboratively lead through networking, facilitating, and problem-solving.
- Strong understanding of the social, economic, and environmental factors that influence community health and well-being, particularly in diverse and underserved communities.
- Excellent communication, collaboration, and facilitation skills, with the ability to engage diverse stakeholders, build consensus, and drive collective action towards shared goals.
- Demonstrated ability to work independently, manage multiple projects simultaneously, utilize critical thinking and adapt to changing priorities and environments.
- Commitment to equity, diversity, and inclusion, with a passion for advancing health equity and social justice in underserved communities.

**Salary range** \$75,000 - \$80,000. 32 hour work week.

**Location** Santa Fe and remote.

**Benefits include** New Mexico Foundation's holiday time off, vacation and sick leave, health insurance, dental and vision insurance, life insurance, short and long-term disability insurance, and a 401(k) plan with match.
